- If it is necessary due to job scheduling to work on non-scheduled workdays (indicated as "***Non-scheduled***" above), the straight time rate of pay will be applicable.
- \*\*Cesar Chavez Day is observed on different dates depending on the city, state, agency or school district. This year, Local Union 11, 40 and 952 agreements observe Cesar Chavez Day on Monday, April 1, 2024.
